## Welcome

Prospective Fire Fighter II Academy Student:

Thank you for your interest in Mendocino College's Fire Fighter II Academy, FSC-90. We are excited about your interest in participating in this program and hope that this orientation packet helps answer your questions and prepares you for success.

## Basic Facts

To enroll in the Fire Fighter II Academy, students must complete several prerequisite requirements and attend two mandatory orientation sessions. One of the most challenging prerequisites is obtaining a Public Safety-First Aid and CPR certification. I encourage students to begin this process as soon as possible to fulfill this State of California requirement. Information about these prerequisites is highlighted in the next section of this packet.

The Firefighter II Academy is made up of two core classes, FSC-90 Firefighter II Academy, and PE-280 Physical Fitness. Enrollment in both of these courses is required for participation.

Both classes will start on December 15<sup>th</sup>, 2025, and the classes are scheduled Monday through Friday from 7 am until 5 pm each day. Classes are estimated to end May 1<sup>st</sup>, 2026, with a Capstone testing process at the College of the Siskiyous in Weed, California. (Capstone testing dates are subject to State Fire Training approval and are estimated.)

Students are required to attend the academy every day. Students who miss more than 5% of a mandated subject matter or are absent for more than 24 hours are dropped from the course, per State Fire Training regulations. Students are required to pass the physical agility test with a score above 80% to complete the academy requirements.

Mendocino College partners with the College of the Siskiyous for the final exam Capstone testing. This structured, skill- and knowledge-based assessment testing process meets strict State Fire Training (SFT) requirements. After successfully passing these tests, students will receive their Fire Fighter II certificate.

To participate, students are required to purchase academy uniforms, rent Personal Protection Equipment (PPE) and Self-Contained Breathing Apparatus (SCBA), and pay for the course's tuition costs. A complete listing of the equipment costs and tuition costs is listed later in this packet. Financial Aid is available to help students participate in this program. You will find more information about assistance later in this packet.





## Prerequisites

To enroll and participate in the Fire Fighter II Academy, students must complete several prerequisites, before enrolling in the FSC-90 Fire Fighter II Academy and PE-280 Physical Education courses

### **Step 1 - Become a Mendocino College Student**

Apply online at [www.mendocino.edu](http://www.mendocino.edu) or complete the Application for Admission (if you are a continuing student of Mendocino College and have been enrolled in one of the last 2 semesters, this is not necessary).

### **Step 2- Complete the Public Safety-First Aid Training Prerequisites**

California State Fire Training requires that each student participating in the Fire Fighter II Academy has completed these courses: (or show proof of Fall 2025 enrollment)

- Public Safety-First Aid, or a higher qualification (EMT, or Paramedic)

AND

- CPR healthcare provider certification or equivalent.

Mendocino College offers two courses in the Fall 2025 semester that meet these requirements: EMS-202, First Aid/Emergency Care/CPR, and EMS-135, Emergency Medical Technician (EMT). Students are encouraged to register early for these courses to ensure availability. Either of these courses meets this prerequisite requirement.

### **Step 3 - Complete a Medical Clearance - Physical Exam**

Visit your doctor and complete a physical exam, and have your doctor complete the Mendocino College Fire Science medical examination and clearance form (attached) – the form must be less than one year old.

### **Step 4 - Submit Documents to Admissions and Records**

Mendocino College uses a first-come, first-served enrollment process, and students should not wait for the orientation sessions to submit their enrollment packets to the Registration Office.

### Step 5 - Attend both scheduled mandatory orientations sessions.

Students must attend these in-person orientations to be eligible to enroll in the class. Students who do not participate in the orientations will not be eligible to enroll in the Fire Fighter II Academy course.

Mendocino College uses a first-come, first-served enrollment process, and students should not wait for the orientation sessions to submit their enrollment packets to the Registration Office. The enrollment process will be completed, and students will receive an email notification of enrollment from Admissions and Records after Admissions and Records have received all prerequisite documents and students have attended both orientation sessions.

Submitting your prerequisite documents holds your place in line for a space in the Academy.

### Baseline Physical Fitness Practice Test – Athletic Gear Required: Tennis Shoes, Shorts, Sweats

During the second orientation session, students will participate in a baseline physical fitness practice test. This test is designed to assess their physical abilities and provide a point of reference regarding the fitness requirements of the Fire Academy. It is advisory, helping potential students understand their capabilities regarding these requirements.





## Academy Costs

Students will be responsible for purchasing uniforms and renting their Personal Protective Equipment (PPE), Self-Contained Breathing Apparatus (SCBA), and Wildland Protective Gear, as well as covering student tuition costs and fees. ## PPE, SCBA & Wildland Gear

Mendocino College has approved "911 Safety Equipment" as our official vendor for rental of Personal Protective Equipment, SCBA's and Wildland gear. Students may use department-issued gear, or are required to rent PPE, SCBA and Wildland Gear. The total cost for renting gear for the Fire Fighter Academy is \$1,378. Students must also pay for shipping and a \$100 security deposit. See the attached flyer for additional details and order online codes.

### *Personal Protective Equipment Specifications:*

**Wildland Boots:** Black in color, heavy-duty, lace-type work boots with deeply lugged soles and heels (Vibram), and leather tops at least eight inches in height. The toe of the boot should be made of a hard material, such as hard leather, to reduce the risk of toe injuries. Steel toes are not required but do give added protection. Can be a dual-compliant boot. NFPA 1977

**Structure Gear:** If you are using department-issued structure gear, it must meet current standards and be inspected at orientation. Structure gear rental is available. See attached flyer.

**SCBA:** If using your department-issued SCBA, it must be a SCOTT SCBA, and you must show proof of fit testing. SCBA rental is available.

**Fit testing will occur at orientation.**

### Fire Science Medical Clearance



To successfully pass the physical fitness portion of the Firefighting course, each student must complete the physical regimen test listed below.

The first 3 activities must be completed within 6 minutes and the fourth in the time specified. Please note that this form can be used *within one year of the date the form is signed off by the physician*. If you begin the course more than a year after this date, *it will be necessary to have the form completed by a physician again*.

**Hose Drag:** The recruit will run approximately 100 yards pulling 200 feet of 1-3/4 inch hose line. The recruit will then pull all hose hand-over-hand into a pile.

**Hose Pack Carry:** The recruit will pick up a 75 lb. banded hose pack and proceed up to the third floor of the tower (stepping on each step), place it down and conduct test item 3 (see below). After Test Item 3 is completed, recruit will carry same pack back down the tower.

**Three Story Hose Hoist:** The recruit will lean out the third floor window of the tower (with safety line attached to SCBA) and pull up the hose roll hand over hand (the weight of the hose is approximately 45 lbs). The top of the hose bundle must touch the bottom of window sill, then be lowered to the ground. Sliding the rope through the hands is not allowed.

**Cardiovascular Test:** The recruit will run 1.5 miles in under 15 minutes. While not part of the physical fitness test, during the Self-contained breathing apparatus (SCBA) test, the recruit will strike an object with an 8 lb sledge hammer 20 times while wearing the SCBA.

In addition to the physical regimen test listed above, the recruit should also be able to walk, run, jump, twist, bend and lift 25 plus pounds for extended periods of time during the Wildland Firefighting course. Your evaluation of the recruit should also take this into consideration.

## Physical Fitness Pre- Academy Assessment Orientation Session #2

### **Run / Walk: 1.5-mile run / 3-mile walk**

Looking for sub-12 min. 1 1/2 run and sub-45 min. walk.  
Minimum of a 5-minute warm-up and light stretching prior to the running event.  
5 min. warm-down, light stretching afterwards.

### **Push-ups:**

Done with legs together, body as flat as possible, down position elbows at a min. of 90 degrees, with full extension at the top.  
Rest while in proper form is OK, no piking (ie. butt in the air).

### **Pull-ups:**

Static hang for each repetition. No kipping. As close as you can get their chins to the bar (bar must be at least even with their eyes), all the way down to full extension.  
(If none can be done, timed 90-degree flexed hang)

### **Front Plank:**

Forearms on ground, toes pointed toward ground, spinal alignment.  
Maintain position for max. time with body off the ground in good form.  
Looking for 2 min.

### **Body Weight Squats:**

Arms at 90 degrees to legs, legs 90-degree angle in bottom position, full extension at the top.

### **Left-Side Plank and Right-Side Plank**

Selected forearm and elbow on ground, raise hips off ground so body is in a straight line.  
Hold for max time.  
Looking for 90 sec. each side.

Capstone testing is May 1, 2026.*
