Whetzel shared the Checklist for Programs that she has been working on and requested feedback. Whetzel further explained that the checklist should be used to help guide faculty when entering a program in eLumen as well to help the committee when reviewing program proposals. Crossman asked about the section that referenced

certificates with a minimum of eight units. Whetzel will clarify that in order to have a Chancellor Office approved program and appear on a student transcript, a certificate needs to be at least eight units. Decker and Mendoza mention they find checklists very helpful. There was also discussion about where to house this information. Whetzel reviewed the curriculum site on Mendocino.edu. Frederickson inquired about adding reference material in eLumen. Whetzel and Nelson will look into that as it is a feature within eLumen.

B. Committee Survey Results

Whetzel reviewed the results from the survey she sent out. There were six responses. For the most part, the responses were consistent. Whetzel addressed a comment about requiring a motion for each course. This is done because the curriculum meetings fall under the Brown Act which uses Robert's Rule of Order. Sometimes courses can be grouped together if the content is very similar. Whetzel also added that the meeting calendar for 2021-2022 will come to the next meeting for approval.
