# CATALOG COURSE DESCRIPTION:

An overview of the historical and contemporary role of psychoactive drugs (including alcohol) in society, emphasizing the physical, social, and emotional consequences of their use and abuse within a general theoretical framework. Topics include the myths, stereotypes, and socio-cultural factors that contribute to the use of alcohol and other drugs, pattern and progression of addiction, prevention and treatment, public policy, community resources, needs of special groups, and special populations. ## **1. COURSE OUTLINE AND SCOPE:**

#### **Objectives:**

Upon successful completion of the course the student will be able to:

- 1. Discuss alcoholism and other chemical dependencies, and their relationship to the general health of the individual and community from a holistic perspective.
- 2. Recognize the various stages in the etiology of chemical dependency.
- 3. Identify the role played by historical, physical and psychosocial factors in people's relationship with psychoactive substances.
- 4. Describe special issues in dealing with substance abuse among specific populations of high risk groups with special concerns, or problems unique to those populations.
- 5. Distinguish between various prevention treatment models.
- 6. Identify and discuss various factors involved in forming public attitudes, as they influence substance abuse treatment and prevention policies and practices.
- 7. Describe the continuum of services or resources available to people experiencing the problems of substance abuse or dependency including professional as well as peer support services.
- 8. Compare and contrast the most abused psychoactive substance in society
