- 11. Other academic and professional matters mutually agreed upon

Title 5 §53200 (d)

District Governing Board is required to *consult collegially* with the Academic Senate and develop policies on academic and professional matters through either or both:



English 60: **This course will provide support for students completing reading and writing assignments from university level courses.** 1 UNIT or .5 UNIT
