INSTRUCTOR – NURSING

Full-time, categorically-funded, non-tenure-track faculty position.

RESPONSIBILITIES

Instructs undergraduate courses, including but not limited to beginning and advanced classroom and clinical coursework in the areas of medical- surgical and Gerontology nursing. Additional experience in maternal- child, pediatric or psychiatric nursing desirable. Experience in designing, implementing and instructing students in a Sim lab setting also desirable

Instructional responsibilities may include but are not limited to the following as outlined in the collective bargaining agreement: Provides instruction in accordance with established course outlines and the schedule of classes; informs students regarding course requirements, student assessment criteria, and attendance requirements; prepares and grades class assignments and examinations; informs students of their academic progress; maintains necessary attendance and scholastic records, submits them according to published timelines; posts and maintains required office hours; maintains course outlines for assigned courses; actively recommends course scheduling; participates in the hiring of instructors; selects textbooks and instructional materials; recommends library selections; submits budget requests; supervises equipment replacement and repair; participates in student advising, student activities, curriculum development, faculty meetings, committee assignments, faculty evaluations, professional development, flex activities, and in-service programs; serves as a liaison with local schools and the community.

OUALIFICATIONS

Must possess a valid, active license issued by the California Board of Registered Nursing.

Must meet the Board of Registered Nursing qualifications for Instructor: A Master's or higher degree from an accredited college or university which includes course work in nursing, education or administration; at least one year's experience as a registered nurse providing direct patient care; **and** completion of at least one year's experience teaching courses related to nursing or a course which includes practice in teaching nursing.

An applicant who does not meet the BRN qualifications above, may instead meet the following BRN qualifications for an Assistant Instructor: A baccalaureate degree from an accredited college which shall include courses in nursing, or in natural, behavioral or social sciences relevant to nursing practice **and** at least one year's continuous full-time experience in direct patient care practice as a registered nurse. If employed with these qualifications, the Assistant Instructor would be expected to meet the qualifications for Instructor by the end of a tenure-track process.

<u>Sensitivity to and understanding of</u> the diverse academic, socioeconomic, cultural, disability, and ethnic backgrounds of community college students.

<u>Knowledge of</u>: Research based nursing skills, physical assessment, medication calculations, human lifespan implications on nursing practice, clinical decision making practices.

Ability to: Effectively instruct assigned courses using a variety of techniques; evaluate and develop curriculum and instructional materials; update course materials to reflect current nursing practice; assess student academic progress; communicate effectively with students and hospital staff regarding student expectations, course requirements, evaluation procedures and other program requirements; serve as a liaison with community health care facilities and staff; follow faculty mandates of the CA Board of Registered Nursing; develop course schedules; stay current in the subject area through continued professional development and active involvement in professional organizations and activities; evaluate faculty; maintain records; prepare reports; work cooperatively and effectively with others; demonstrate respect for the rights and needs of students; communicate effectively both verbally and in writing; work variable locations and hours.

Assignment: This is a full-time, non-tenure track faculty position. The expected length of the assignment will be one year, renewable upon satisfactory performance and available funding. The teaching load is fifteen equated units per semester (=15 lecture hours per week, 20 laboratory hours per week, or a combination thereof). The annual work year includes 166 instructional days,

2 mandatory flex (professional development) days, and 7 individually planned flex days (42 hours).

This assignment may include day, evening, and weekend hours, as well as travel to, and instruction at, off-campus centers and various clinical sites in and out the District.

The maximum entry level is Step 7 of the appropriate column. There is also a \$2,720 doctoral stipend. Ten days of sick leave are earned annually.
